



Loaned Equipment Agreement Terms & Conditions

1. Borrower acknowledges that he/she has received the equipment listed on the obverse of this document in good condition, from Innovative Fluids, LLC, and that he shall keep said equipment in good condition and repair. In addition, Borrower certifies that he will insure the equipment against all risks, that he will not sell, encumber, remove or otherwise dispose of said equipment from the place where said equipment is to be located, indicated on the obverse hereof.
2. It is expressly understood and agreed by the parties that the equipment being borrowed is, and shall remain the property of Innovative Fluids, LLC.
3. Borrower acknowledges that the items listed on the obverse are loaned to him at the specific request of the Borrower with the express intention and certification that they will be used by him on the stated premises, for storage, handling, dispensing and sale of products supplied by Innovative Fluids, LLC and Borrower has indicated to Innovative Fluids, LLC his intention to use the items for such purposes only.
4. Borrower further acknowledges that Innovative Fluids, LLC. loans the equipment, and the Borrower accepts same, without any warranty, express or implied, on the part of. Innovative Fluids, LLC. Borrower hereby further agrees to indemnify Innovative Fluids, LLC. from any liability whatsoever arising out of said equipment and shall pay all costs of installation and maintenance of such items of equipment and does hereby assume total responsibility for all personal property taxes, assessments, license fees or other charges which might be levied against said equipment, its use, installation and/or maintenance.
5. Borrower acknowledges that failure to pay for any purchases of product supplied by Innovative Fluids, LLC. when due, or breach of any part of this Agreement, in any way, the Borrower shall, upon demand, without any additional notice, immediately surrender and return to. Innovative Fluids, LLC all equipment and other items loaned to him; in such an event, Borrower further agrees to allow. Innovative Fluids, LLC to enter onto the premises where the equipment is stored and remove said items without recourse to process of law.
6. The Borrower further acknowledges, and agrees to, the additional right of Innovative Fluids, LLC at its sole option, to demand the return of all loaned equipment, without any specific breach, upon five days' written notice.
7. Notwithstanding the above, Innovative Fluids, LLC hereby grants to the Borrower an option to purchase the equipment, as a unit, and not in any individual parts at any time. Upon request Innovative Fluids, LLC will provide Borrower with the cost of the equipment and the depreciated value thereof.
8. The written Agreement contains the entire understanding between the parties. Any verbal stipulations of the parties or their representatives are deemed to have been merged with the Agreement, unless otherwise specifically set forth in writing and executed by all parties, subsequent hereto.
